MINUTES

1. Opening of the General Assembly

Dimitris Assimakopoulos, President of EDAMBA welcomed all members present and opened the meeting with a review of the agenda. He welcomed Gerardine Doyle, EIASM President.

2. Approval of the General Assembly - Online, September 25, 2020

No comments were made. The minutes were approved.

3. Report on main EDAMBA activities in 2020-2021

3.1 Thesis Competition

Agnes Zsoka, EDAMBA General Secretary reported on the 2021 Thesis Competition.

- 40 submissions were received from 21 member schools and 17 countries.
 Agnes made a call to all members to nominate their best candidates to participate in the Thesis Competition.
- The submissions were of very high quality.
- Reviews were completed according to a blind review process. Agnes briefly explained the review process of the competition.

This year 27 reviewers performed this important task. She thanked the reviewers. She also mentioned the need to recruit reviewers for the next competition. A special thanks was made to the selection committee which comprised of Dimitris Assimakopoulos, John Ulhoi and Agnes Zsoka.

This year EDAMBA has awarded four (4) prizes, due to the high quality of the papers submitted – two papers were awarded the 1st 'prize.

3.2. EURAM-EDAMBA Webinar on the Future of Doctoral Training and Supervision in PhD and Professional Doctorates in Management

François Collet reported on this EURAM EDAMBA joint initiative. A panel comprising of EURAM and EDAMBA members in different types of doctoral programmes was set up. François Collet, EDAMBA and Stefan Gueldenberg, EURAM were the conveners. Two main themes were on the agenda:

- Dealing with the Demands of Doctoral Training and the Labor Market
- Competing pressures, training, and recognition of supervisors

The topics discussed were:

- Supervision
- professionalisation of doctoral supervision
- Impact of Covid 19 on doctoral education

In an effort to foster the conversation with the EDAMBA members, François asked the members to think about focused and interesting seminars that would be of interest to all members and to send the ideas to Nina Payen or François Collet.

Both François Collet as well as Dimitris Assimakopoulos stressed the importance of the topics discussed.

The webinar welcome 60 delegates worldwide - Europe, Latin America, South Africa, China, Malaysia.

EDAMBA wished to pursue such activity in the future with EURAM.

Dimitris also emphasised the real opportunities that exist to engage with other members from different countries and different doctoral programmes. The webinar format is a good opportunity to pursue these initiatives

3.3 Summer Research Academy

In absence of May Seitanidi who led the Summer Research Academy, John Ulhoi reported on this year's academy. Unfortunately, due to the COVID 19 Pandemic, the 2020 Summer Academy was postponed. The 2021 edition was organised online from 19-23 July 2021.

The intensive 5 days event was structured into

- plenary session and students' presentation sessions,
- 2 stages Early Stage & Advanced stage and,
- 3 tracks Early Stage Qualitative, Early Stage Quantitative and Advanced stage

The programme was diverse with keynote speeches from

- Prof. Ann Langley, HEC Montreal on "Beyond the Thesis: Scholarship as a Process"
- Prof. Claus Rerup, Frankfurt School of Finance and Management on "Spaghetti junctions: Footnotes on turning rich data into theoretical insight."

The other plenary speeches were from Prof. Joe Hair, University of South Alabama, Prof. Xavier Castaner, IFSAM; HEC, Lausanne University, Prof. Elias Carayannis, George Washington University, Prof. Pierre Batteau, Marseille University, Prof. Dimitris Assimakopoulos, Durham University (visiting Professor) & EDAMBA President and Prof. John Ulhøi, *Aarhus University*

23 students from 9 countries, European countries but also from Latin America, U.S.A, Malaysia attended the event. It was an enriching online experience.

John Ulhoi thanked the organising committee which comprises of Dimitris Assimakopoulos, Jose- Antonio Robles-Flores, Hans Siggaard Jessen and May Seitanidi. He also thanked all presenters. A special mention was made for Hans Siggaard Jensen who with Pierre Batteau have been at the start of the Summer Academy. They have contributed to the success of the Academy over the years. A life-time award for both Hans and Pierre.

4. EDAMBA Strategic Alliance

Dimitris reported on EDAMBA strategic alliances.

Collaboration with AACSB

The collaboration with AACSB resulted in the two joint surveys and a series of interviews with programme directors on Mapping the Global Landscape for Doctoral Education. The outcome is a report that evaluates the global landscape of business doctoral degree programs. The report can be found on the EDAMBA website.

A follow up session might be organised to continue to conversation on this subject.

EURAM-EDAMBA Collaboration

Dimitris thanked François Collet who initiated this collaboration. He referred to the reporting on the EURAM-EDAMBA webinar and stressed the importance of such initiatives. The webinar was a success, and it is important to build momentum and follow up with EURAM.

EDAMBA-EIASM Collaboration.

EDAMBA has an on-going collaboration with EIASM. Dimitris indicated the necessity to follow up and continue the work done on the European Code of Practice – a joint collaboration between EDAMBA and EIASM. Gerardine Doyle, Dean of UCD and EIASM President mentioned that EIASM with the Executive Director Jérôme Chabanne-Rive

supports the collaboration and is very keen to further collaborate with EDAMBA. Any interesting idea or thought can be forward to Gerardine Doyle and Jérôme Chabanne-Rive.

Dimitris emphasised the opportunities of collaboration with other associations under the umbrella of EIASM. These could give a horizontal perspective.

EQUAL

EDAMBA is also involved in EQUAL. Dimitris reminded the EQUAL guidelines which are based on the European Code of Practice developed by EDAMBA and EIASM. Since 2016 these guidelines have been adopted by the EFMD as the EQUIS Standard for Doctoral programmes. EDAMBA is still participating in the different discussions and EQUAL Board meetings.

5. Financial Report

5.1. Annual financial report 2020-2021

In absence of May Seitanidi, John Ulhoi reported on the financial situation.

Revenues

He presented the EDAMBA income statement and balance sheet for the year 2020-2021. *Income:*

- The main source of Revenue comes from membership.
- There is a small income from the Summer Academy due to the low fee applied for this online format.

Expenditures

This year there were not the 'normal' 'expenditures.

The main expenses related to the Thesis competition prizes, the administration of the association and its day-to-day management, the new EDAMBA ICT projects and expenses related to strategic alliances

John highlighted some points:

- EDAMBA has made a surplus of 29.935,10 Euro. This surplus was mainly due to no costs related to the Summer Academy.
- We are a non-for-profit association and as such EDAMBA's interest lies in contributing to EDAMBA members and not keeping the money in the bank.

EDAMBA has accumulated some reserves in the bank accounts, as can be seen in the balance sheet.

The budget of 2020-2021 was approved

4.2. Estimated Budget 2021-2022

The budget for 2021-2022 is based on class activities and consequently, the association would incur more expenses, mainly for the Summer Research Academy. He reminded that the Summer Research Academy is the most expensive item in the budget, due to the fact that EDAMBA highly sponsors the PhD students.

The estimated budget 2021-2022 was approved.

EDAMBA is in a healthy financial situation. The money can be used to finance useful projects.

6. Executive Committee Elections

No members stepped down from the Executive Committee.

It was also confirmed that:

Hans Siggaard Jensen, Aarhus University is no longer part of the Executive Committee; the mandate ended on May 9, 2011.

and

Mr Soumitra Sharma appointed at the meeting of May 9, 2008, for a term of three years, whose term of office ended on May 9, 2011; the mandate has already been revoked for a long time and the former administrator having had no connection with the association for several years.

The constitution of the Executive Committee 2020-2021 was unanimously approved.

Dimitris Assimakopoulos mentioned the continuous contribution and support of the EDAMBA honorary Presidents Hans Siggaard Jensen, Pierre Batteau and Eduard Bonet, who are still actively involved the different EDAMBA activities such as the Summer Academy, the Consortium, and the implementation of the Latin American Chapter.

As honorary member, Prof Ruan from Tongji University is supporting a new project with EDAMBA in China.

7. EDAMBA membership

63 members for this current year 2020-2021

There was no new member in 2020-2021. There were some interests, but due to the Covid 19 situation no appraisal visit was conducted.

EDAMBA sill gives a priority to membership. It is important to rethink the membership strategy. A task force will be implemented for that purpose. Dimitris made a call to all membership for any idea or thought on this matter. EDAMBA needs to engage with its members, via seminars, meetings, webinars, or other projects.

8. Future Annual Meeting

EDAMBA is hoping to organise its 2022 Annual Meeting in Riga, Latvia. It will be the 3rd try as due to the Pandemic situation, the Annual Meeting and General Assembly 2019 and 2020 originally scheduled in Riga did not take place in face-to-face format but were organised online.

2022 Annual Meeting & General Assembly is now scheduled again in Riga, Latvia and Anna Strazda from the Riseba University welcome all members to Riga in 2022.

9. Open questions

To conclude the General Assembly, Pierre Batteau, Honorary President reminded that EDAMBA will be celebrating its 30th anniversary and EIASM with whom EDAMBA has long standing relationship will be celebrating its 50th anniversary. He briefly recalled the start of EDAMBA and its collaboration with EIASM. It started in the Summer 1990 in Aix en Provence, when Tony Berry suggested to create an association; some rules were defined and the Ist General Assembly was held in Stockholm.

Closing of the General Assembly

Dimitris Assimakopoulos thanked all members for their attendance and closed the meeting.
